The D/C says:

When Patsy & I were just married, we did a couple of month's lookout duty for the US Forest Service in the Absaroka (pronounced "aB-sorkee") Primitive Area in Montana. If you draw a semi-circle on top of Yellowstone National Park, that's the Absaroka. Just about as neat a place as you might want for a working honeymoon. We were perched on the top of a 10,000 foot peak on the edge of a 1,000 foot cliff, with a view of 30 miles or so.

Part of the job was plotting lighting strikes, taking bearings and counting time to determine distance. At that height, we were in or near most of the cumulonimbus formations as they passed by. The tower was protected on all edges by 3/8" copper cables and solidly grounded, so that it was safe to be there. When a storm approached, if you went outside while the storm was still a mile or so off, the grounding system would be humming in a deep, very distinct tone, as if feeding on the energy and calling for a strike on our location. It's a humbling experience to feel the power of God's creation at work.

In USPS these days, there is the energy of change in the air. With the grim realities of our membership decline forcing some real creative thinking, you can feel the energy of the Idea Storm approaching. There will be change, some will be good, some will make us uncomfortable, and some will no doubt be counterproductive, but there will be change. National is proposing a 3 year waiver of the educational requirement for membership, USPS University, a boater certification program, and a revamping of the entire governance of the organization. In our own district, we have eliminated winter council and its associated training event, and I have initiated a review of needed changes in our operations to cope with the changing National Calendar and our own changes. The squadrons too, are feeling the pressures and attempting to cope with the changes in the cul-

At the rendezvous, we held a short special District Council session to approve the training plan developed by our Ad-Hoc Committee on Training. With that authority, your bridge will be developing a training regimen for incoming officers which will begin with this Fall conference. In addition to training, we will be presenting a recertification session for instructors teaching public classes, DB2000 training, and something of general interest. It will be a jam packed, information filled weekend that you won't want to miss. In addition, the Pirates of Pigs Eye will be on the loose, arrrrrgghhh!

So strap on your Pirate gear and head for Hudson, WI., end of September for a swashbuckling good time, the electricity of change in the air, and the good companionship that is USPS.

Consider attending both District conferences and the National meetings where these and a lot other matters which are central to USPS will be topics of discussion, along with a good time being had by all who attend. For example how do you feel about the motion which will be brought up at the NY Governing Meeting to eliminate the educational requirement? No matter what happens at NY educational issues for USPS will continue to be hot topics among our members.

My commitment to D/10 and USPS is still strong, but appears to be going in new directions, especially towards teaching education courses, VSC and Cooperative Charting. The moral of my story is that there is something for everyone in USPS; find your niche and expand your horizons with us.

Legislation

Cooperative Charting

There will have to be new criteria for the Cooperative Charting trophy and this will be presented at the Fall Conference. At present the Biddicks (Sturgeon Bay) and the Andersons (Green Bay) are leading the pack and we have a long way to go to catch up with last year's production, but there is a long time to go before the end of the Cooperative Charting Year in March of 2007. P/C Dave Biddick will give another presentation at the Fall Conference on how to report your found marks. That is another reason to attend the Fall Conference at Hudson at the end of September.

Vessel Safety Checks

VSC as of August 1, there were 575 completed VSC reports sent to National by 76 VE. There must be a lot of forms which have not be turned in to Squadron Vessel Safety Chairs or reported to National. Last year our final figures were 86 VEs who completed 856 reports. We need to get going with enrolling more VEs.

Public Relations

All Squadrons are participating in the program and now it is time to get your publicity for the fall classes in order and then to file for reimbursement. The next deadline is October 31. So don't miss your chance.


District Educational Officer Says:

Plan now to attend the D/10 fall conference at Hudson Wisconsin hosted by the Saint Paul Sail and Power Squadron on 29 September to 1 October 2006. As most of you know, the fall conference emphasizes the educational aspect of USPS. This year will be no different. We plan to hold a two-hour instructor recertification seminar. The presenters will be P/Lt/C Jenny Rice, S and P/D/C Ron Kraase, SN. All USPS certified instructors in attendance will have their certification extended by four years to September 2010. We will have the usual teaching aid competition. (See separate article from ADEO John Winger, SN for more details.) We also will be giving educational awards to instructors and to squadrons including the prestigious Prince Henry and Squadron Educational Achievement (SEA) awards.

For those members who are not as yet certified and wish to teach any of our public boating courses, you must fulfill all of the requirements of the Instructor Development course to obtain USPS certification. Encourage your squadron educational department to hold that course every year. Squadrons can also conduct the two-hour instructor recertification seminar.

The district educational department is asking for your help. I am trying to update our history of the District 10 Chapman Award winners. I can find records back to 1998. Before that time I can either find inconclusive records or no records at all.

Did you ever wonder?

"Three Square Meals A Day":

In the days of wooden ships and iron men, the crew ate their meals on long, narrow tables which had wooden railings around the edges, called "fiddles". These railings formed a rectangular pattern on the table top and kept things from falling off the table. Sailors were served their meals on square wooden plates that just fit into these rectangular, table top spaces which, by design, kept the plates in place, even if the ship was pitching and rolling. Therefore, since the sailors were served their chow on a square plate and ate three times day, they got "Three square meals a day."

On the positive side, we have been anticipating these events, and are therefore prepared. In the meantime, I am working with the bridge and committees to plan next years budget, to be presented at the Fall Conference at the end of September. There will be a detailed report of our financial position for all members in attendance.

Radio Technical Report

USPS and the American Radio Relay League (ARRL) are working together to promote Amateur Radio to the Public and ARRL Members. Imagine being able to talk to fellow boating entuhiasts across the marina, country, or world, catching up on stories of their voyages, or assisting them in times of need. This is only one aspect of the fun you can have as being a radio amateur.

Amateur operators also known as "Hams" also participate in many other civic events. Hams are severe weather spotters for the National Weather Service, provide communication facilities for community events, and work with local, state, and federal disaster agencies in time of crisis. Imagine being able to communicate directly with the astronauts aboard the space station or the space shuttle!! Both of these platforms have amateur radio equipment aboard, and most astronauts are Hams, who enjoy making contact with their fellow earthbound counterparts.

Over the years Hams have been on the forefront of technology, by being the first to communicate long distances without wires, developed the digital technology that commercial satellite providers use to beam TV direct to your home, as well as many other advances in technology to numerous to mention.

If all of this sounds interesting to you, contact an Amateur operator in your community. Some have operating stations, known by fellow hams as "shacks", that the US military would envy, others are less sophisticated, but all would love to share the amateur story with anyone interested in the hobby. Almost every county in the USA has an Amateur Radio Club, whose members welcome those interested in radio communication. The website at ARRL.org has a listing of clubs affiliated with the ARRL as well as more information on how to obtain an amateur license from the FCC. USPS DISTRICT 10 TRAINING AIDS AT FALL CONFERENCE

Actually, we should have lots of training aids every time from every squadron because everyone knows how to make them. But we don't. That's probably because people think we're looking for something we aren't. We aren't looking for some way to clarify Einstein's general theory of relativity. Or an economic model for predicting stock prices with uncanny accuracy. Nope. Our subject is safe boating. We want simple, effective ways to teach people the techniques of safe boating. There are lots of skills to be developed by each boater, lots of small things to be learned in order to build a store of knowledge capable of dealing quickly and calmly with the myriad of possibilities that boaters can face out on the water.

Everyone spends a lot of time each day explaining things to other people. Frequently, people line up saltshakers to explain how things were positioned or make quick sketches or use analogies to other events to get their idea across to family or friends or business associates. So that's why I say everyone knows how to make teaching aids. All we need is some inspiration for turning that talent toward teaching safe boating. Maybe you're now thinking back about each boating class you've taken and trying to remember what training aids were used then and what improvements or additions there could have been. Well, that's one good approach, but I'd like to suggest another. The next time you are boating, or just down by the water, you are going to see a lot of people doing a lot of things and you will probably see some unsafe actions or maybe just mistakes or some extra struggling to get some task done. More importantly, your entry will help us all to look for training opportunities and creative ways to spread the safe boating message.



District Training

The Ad Hoc Training Committee was created at the 2006 Spring Conference to make recommendation on future officer training. The report of the Committee was given and approved at the Special Council Meeting held at the Milwaukee Rendezvous. The full report can be found on the District web site. It addresses the need to preserve training opportunities for officers historically done at the Winter Council, in light of the elimination that meeting. The report consists of 11 points which are summarized below:

- 1. Training can be effective if given at our two district conferences and supplemented by informal training and effective use of the district's web site.
- 2. At the Fall Conference there would be a "New Officer Training School" which would outline the functions and general expectations of the various department squadron leaders. This would include the minimal amount of information necessary to give these incoming officers the essential duties that need to be accomplished by that department. This session would be held on Sat. morning of the Fall Conference and last no longer than 2 hours.
- 3. At the Spring Conference training sessions would relate to "Continuing training and Focused Assistance". The purpose would be to train the current officers in what they need to know about their continuing duties and introduce to them any new material and issues. This would include things like national policy, tools, tips, and methods to make their job easier and their squadron run better. This would also include updates on new ways of doing the tasks of the office. These sessions would also not exceed two hours on Sat. morning of the Conference.
- 4. Delivery of materials and ideas through available technology will be an important supplement to training. The D/10 web site should have as a minimum: the star squadron outline, all officer manuals and training materials, hot links to National Department web pages, instructions for obtaining updates and a list of people who have "done that before" and will give help. District bridge officers should provide squadron officers with outlook files with deadlines and guidance by email monthly, except in the summer. These outlooks should be available for downloading from the D/10 web site and updated on the site regularly. Continuity in training outside of the conferences is very important. District training should have a large degree of similarity in style and function with content dictated by the needs of the office.
- 5. Particularly at the Fall Conference these training sessions would be open to any interested member. Candidates for an office and those uncertain of their interest in a position would benefit greatly from better understanding of the jobs available in the squadrons and district. It would be helpful if each squadron's nominations committee could complete their work by Fall Conference.
- 6. The committee will work with the District Bridge towards the monitoring, adjustment and adoption of the training plan through the Spring Conference 2007. To encourage general member attendance, conferences need be more than training events; otherwise general members will be discouraged to attend.

In the early morning on Thursday, May 25, 2006, Lt/C David Lee Hegarty, P, left us unexpectedly leaving a void in our hearts and our organization. The jovial Irishman, always a twinkle in his eye, was able to get fellow members to participate in the Mission of USPS and the Milwaukee Sail & Power Squadron. On a vacationer's moment's notice, David could prepare a Co-Op Charting packet, filled with geodetic marks eligible for recovery anywhere in the United States except for P/C Dave Biddick's territory. During his last weekend on this earth, Saturday, May 20, David taught the "GPS for Mariners" Seminar.

On the Wednesday evening before he died, David assisted on the *Boat Smart* re-exam night by helping a reading im-

paired individual get through the exam. As the representative of MS&PS's Bridge, he then passed out critiques and congratulations to several who passed the exam that evening. During the night, he complained of a pain in his back and passed away in the early morning.

David was an individual who devoted his energies for the benefit of others. He joined the Milwaukee Sail and Power Squadron in October, 2002 and immediately went to work to advance the mission of MS&PS, working tirelessly to lead the co-op charting program and assisting in planning the staffing of Boat Show booths. He continuously worked the Boat Show booths, volunteering countless hours to insure the booth was always manned. For some Boat Shows, he was present for 40% of the time. He also volunteered his time and expertise as a certified Vessel Examiner and Bridge Officer, serving first as Secretary and most recently carrying out the many responsibilities as the Milwaukee Squadron's Educational Officer. This is a very demanding position and David embraced it with passion, intelligence and a contagious spirit.

Not only did David oversee all of the squadron's educational activities and administration. he chose to teach the Seamanship Course and co-instruct for the Boat Smart classes. Moreover, if this was not enough, he participated in District Conferences and he championed a new venture to grow the Milwaukee Squadron's 'hands-on' educational opportunities by spearheading a boat restoration project that will teach students about the safety requirements that must be considered during reconstruction of a vessel. To keep this important activity alive, Karen and Mike Beckmann will oversee the completion of this project and will name the vessel the David Lee in his honor...

David's contributions to the Power Squadron were numerous and will take us some time to rebuild.
