# **District Educational Department**

We're just fresh off Lake Michigan after a several day trip. This year, most days the wind was fairly strong, with average wind speeds around 15-20 knots and 2-4 foot waves, with occasional higher seas. We're sailors, so this is exciting, but there is a catch. We have a Seaward 25, which is a fairly light, shallow draft keel boat, great for trailering and gunkholing, but which requires us to reef (reduce sail) earlier than most sailboats. Too much sail and the boat just leans over and sails poorly, too little or not configured right, and you lose a lot of speed. Get the balance right, and it's a rocket ship, wrong and it's a real pain, mentally and physically.

Like the winds in our favorite environment, the winds of change are blowing hard through our organization again this year and especially in education. When last I was DEO six or so years ago, we had a lot of changes in the coursework, but the basic pattern of classroom instruction in Boating for the public and Advanced Grades and Electives for members had been stable for some time. Though comfortable for many, our enrollments continued to decline, signaling that whatever we were doing wasn't working. In the language of business, our markets were no longer responding to our product offerings. It's said that nothing focuses the mind more than the prospect of one's own execution. The painful cutbacks in our staff support and program budgets sent a clear signal that this was going to end badly if we didn't figure out a method of doing things that was attractive to our markets and our members.

In education, the organizational response has been frenetic. The winds of change have blown in: eighteen member and public seminars; commercial texts used in some of our coursework rather than member developed materials; on-thewater education to eventually tie to all our coursework; the option to open previous member classes without a membership requirement; Boat Operator Certification including on the water skills demonstrations for the first of four eventual levels and leading to an internationally recognized credential; USPS University with it's open structure; extensive new content modernizing our existing coursework to name a few.

Just before I sat down to write this another big wind of change has blown in. That is a blossoming of the storefront concept into a massive new strategic partnership with Brunswick (the world's largest boat manufacturer). In a pilot project heavily involving District 10, Brunswick will support our mission at their facilities. To quote the National Education Officer, R/C Bob Sweet, SN "... The dealerships will provide us with space, cooperate in promotion, and loan us boats and dock space depending on local agreements. The dealers will also join USPS. We get a space to operate, new members, and access to the dealers customers....." Of course, they are eagerly awaiting the traffic into their stores and the prospect on add on sales. This has some rather awesome implications for us, both as opportunity and as risk. It's critical that we get the balance right, and make as much of this opportunity as we can without becoming overwhelmed. While this is a pilot, it's worth considering that there are 1,500 dealerships and less than 500 squadrons. So just how we do this will be a major workshop topic for us this fall.

At the Seattle meeting, the Coastal Navigator Certification

program was released. The skills demonstration requires planning and executina а route. Amongst the other requirements, the Marine Compass seminar required, which you can pick up at the fall Conference, taught by our former DEO, P/D/Lt/C Bill Dohr, SN. See the back page of this publication for more information on this seminar. Also at the meeting, we received word that beginning in December, the classroom America's Boating



Course can be offered with a 6 month trial membership. In that regard, we have a lot of expiring instructor certifications so we will be offering a new version of the Instructor Recertification Seminar, with an emphasis on successful On-The-Water events. It's being written by our own P/R/C Art Mollica, SN, and your feedback will help improve the course for all of USPS. Even if your credential is not expiring quite yet, taking the class will update your certification window.

At the end our short trip, we met up with our squadron at their annual rendezvous and a great time was had by all. But just as we left the harbor, the wind died and we had a slow hot motor in the still air the many miles home. The moral, to both stories interwoven here, is that its preferable to live, even with a bit of fear, by tempting the edge of your skills in the winds that blow strongly through our lives.



# **District Executive Officer**

#### Success Again for D10!

In my spring article, I talked about challenging our Squadrons and District 10 to try new things and expanding our horizons. That's what we have done so far this year in the Executive Department. We are finding new ways for our members to get involved, identifying what the next generation of Power Squadron member's want, and making our organization more attractive to fellow boaters. We have conducted VSC's, took our message to other boaters during Safe Boating Week, participated with local marinas during National Marina Day, introduced new squadron activities, and did more events on the water.

Nothing exemplifies our success more than the PR category. As I am writing this article, I am returning from the Fall Governing Board meeting in Seattle, WA. I am very pleased that our success continued at the national level. Many squadrons and members were recognized for their efforts and many of the entries won because they had tried new things within their organizations. Mark and Tyler Hanus of Minnetonka won the Roger Upton Award for the second year in a row for best video on a topic promoting USPS civic services shown to a public audience. They are shown in the picture below receiving the award for their video about the 2009 District 10 Fall Conference from V/C John Alter, along with D/C Jim Pahl-Washa, and me. Also, Tami Johnson of Minnetonka won the Carl C. Mahnken Commander's Cup for best slide show or computer generated program on a topic promoting USPS civic services shown to a public audience for her PowerPoint slide show of photos and music from around District 10. Our District was also recognized for other efforts to promote USPS by using multiple electronic media venues like You-Tube and Facebook, as well as utilizing local community cable TV stations.

The Executive Department has been busy in many other areas as well. We continue to work with the national organization's Squadron Development Committee on a Provisional

Squadron in Dubuque, IA. We also are looking into the impact that National's new unified membership will have District/Squadron Bylaws and new partnerships that have been created with boat manufacturers. We are looking at ways D10 can assist the U.S. Coast Guard with its "America's Waterway Watch" campaign and also promoting the USPS "America's Waterway Awareness' program. Finally, this is the last year of the Co-



operative Advertising program and I encourage each of the squadrons to submit their request for funds to National by October 1<sup>st</sup>. Many of these topics will be discussed further at the D10 Fall Conference in Green Bay, WI.

I am often asked about what other areas of responsibility fall under the Executive Department and I thought I would take this opportunity to provide an update of some of those areas. The Cooperative Charting Program is a major public service of USPS. Under it, members supply information to the Marine Chart Division of NOS/NOAA leading to corrections to nautical charts, small craft charts, and Coast Pilot publications. They also supply data on depth surveys, range status, and formerly, geodetic marks. The Adopt-A-Chart subprogram provides for individual squadrons to assume responsibility to keep a chart or a portion of a chart in their local boating area up to date and get recognition on new editions for their work. We have been told that the Cooperative Charting Program is recognized as the most effective user-participation program in all of the Federal services and many of our squadrons are actively involved with this program.

Our Environmental Committee of USPS promotes coastline, beach, and waterway clean-up efforts through the volunteer efforts of our membership. Boaters help by removing trash and debris found in waterways that cannot be accessed directly from the shore. I am proud of our Squadrons as many have adopted shoreline, lakes, and beach areas. USPS is now a partner in the ANS (Aquatic Nuisance Species) Task Force public awareness campaign "Stop Aquatic Hitchhikers," sponsored by the U.S. Fish and Wildlife Service and the U.S. Coast Guard.

# **District Administrative Officer**

I'd like to start by saying "thank you" to all of the members of the Duluth Sail and Power Squadron for the work they did to put on the 2010 D10 Rendezvous in Bayfield. I'm not going to go into any detail about the event; you can read about it other places in this newsletter. I will say that it's a hard act to follow, but I am confidant that Door County will also hold a memorable event next year. Set aside 5-7 August 2011 for that event.

Many other events have happened at other squadrons around the district throughout the summer. Thanks to the efforts of Boating Activities Chair Suzanne Carman, anyone could go onto Sail Angle and check out the activities that were on the calendar. What's that? You say you're not on Sail Angle? It's easy, and it's the best way to find out what's going on at all levels of USPS. As of the moment I'm writing this, only 103 of our fellow D10 members have signed up. To make it work, we need greater participation than that. To sign up, go to the USPS home page at <a href="http://usps.org/">http://usps.org/</a> and click on the Sail Angle button. On the next page, log in and you're done.

Membership is always a topic in this department. Over the last few years, the news has rarely been good, but now there is guarded optimism that we may be turning the corner. Nationally, the rate of loss is slowing. The renewal rate is at 92%, up from the goal set nationally of 88%. Additionally, the Cyber Squadron has brought in over 800 members; this represents a huge recruitment opportunity for squadrons. When National alerts your squadron that a new member is looking for a squadron, contact them! You are practically being handed a new member.

I am happy to report that membership for D10 is up 63 members for the period of 1 April 2010 to 30 August 2010. Our membership at the end of August 2010 was 1221. We should in no way be complacent about those numbers though. If we compare the same period in 2009, the numbers reflect the same trend- in other words, we gained 75 new members over the same period. A more important number may be the comparison between August of 2009 at 1319 and August of 2010 at 1221, a loss of 98 members. For those squadrons that have experienced growth this watch year, congratulations and keep up the good work. For those who are still struggling, keep trying. Getting the safe boating message out there is important work and worth the effort.

The 2010 Fall Governing Board Meeting took place in Bellevue Washington at the end of August. Many new programs and other developments were presented to attendees. Among them were:

Unified membership. Excluding special classes of membership such as corporate memberships, there is now only one type of membership; that is active. It will simplify the whole dues/membership structure. It will require squadrons and districts to look at their dues structures in order for them to bring their proceD/Lt/C Richard Baker, AP

dures into a lignment with National. We have 18 months to do this.

Free trial membership. For people taking the ABC3 course, a free 6 month trial membership is offered. The new member must be signed up online.

**fits**. A new package of 12 benefits is now in effect that includes travel, health, cellular services and a whole new suite of insurance services. While not directly related to boating, these benefits still may help sign up that prospective new member. The new benefits website is at <a href="http://uspsbenefits.org/">http://uspsbenefits.org/</a>.

Initiation fee dropped. As of 1 December 2010, the \$25 initiation fee that has been charged to new members will be dropped. This obviously makes membership in USPS cheaper for the new member, which should help sign them up.

PIN. As of now, there are two levels of security on the National web site. If you use your zip code as before when you sign in, you will get a basic level of information. If you use your PIN, you will get a higher level of info equivalent to what you used to get. This means, to effectively conduct any business on National's web site, you MUST use your PIN. Lost your PIN already? Go to the "How do I" section of the National website. Select "Get My PIN" and follow the directions.

By the time you read this, we will be very close to the 2010 Fall Conference in Green Bay, but fear not, there is still time to sign up. The Green Bay Sail and Power Squadron has provided several fun things to do for the "non working" members who attend. For the rest of us, our fall meetings are our "educational" conferences, so you can expect our usual high quality offerings. If you have never attended a district conference before, this would be a good one to start with. Please keep in mind that this is a Packer weekend and rooms will not last long. # **District Treasurer**

# Buried Treasure Thoughts from D10 Treasurer Kris Harmon, AP

As the new District 10 Treasurer, I've been wondering just what it is I'm to be treasuring. So I asked my old friend Merriam Webster, and determined that I am to be the guardian of District 10's treasure (as in Definition #1 – wealth or store of money in reserve). And I understand that; I collect dues, I write checks for legitimate, approved, budgeted expenses and I report a summary of such transactions to the D10 membership. This is easy; I can do this. Like most people, I think I understand the value of money.

What am I having trouble with is why so many of us today have concerns regarding the price of membership in USPS and in the District's role. I think I've heard the question one (or one hundred) too many times: "What am I getting for my money?" So I'd like to take a stab at answering that question. (Bear with me, I'll be getting back to the treasure part.)

The annual dues paid by all members of District 10 are split three ways.

The first \$58.50 of the dues paid by each Active Member (with additional actives) goes to National. What do you get for this money? Tangibly, among other things, you get an organization that works to partner with related organizations and associations to give you discounts on everything from your vessel insurance to a new Dell computer. [Does your insurance discount equal or exceed that \$58.50 per year? Ours does.] Intangibly, you get an organization that actively campaigns for safe boating legislation, boating safety equipment, safe boating awareness, your own boating education and more. And yes, some of the expenses of the volunteers who make all this happen are reimbursed. [It's a good thing we don't pay for their time; those dues would be outrageous!]

The next \$21.00 of your Active Member plus additional(s) goes to District 10. \$21.00. Per year. What do you get for this money? Tangibly, among other things, you get space to convene meetings, speakers who edify and/or entertain you at those meetings, a website and this newsletter. And you're once again reimbursing a portion of the expenses incurred by the volunteers who translate and transfer everything that happens at the National level (see above) to the local scene. [Again, it's a good thing we don't pay for their time; those dues would be outrageous!]

The rest of your dues vary by and go to your individual Squadrons. Feel free to ask your local Executive Committee how your squadron spends your dues money.

OK, now I've told you where your dues money goes, what you "get" for it. Are you getting anything you're not paying for? How much value you place on what you get is strictly up to you. And that's

They coordinate USPS safe boating promotional efforts through the National Safe Boating Campaign. Mark your calendars, the kick-off week for the 2011 campaign is 21-27 May. All of our Squadrons have been encouraged to plan safety events. Every Squadron Safety Officer is encouraged to submit a report for their squadron to our District Safety Officer before 1 October. Our goal is for all squadrons to earn Safety Honor Roll status each year.

The mission of the VSC program is to minimize the loss of life, personal injury, property damage and environmental impact while maximizing the safe use and enjoyment of U.S. waterways by recreational boaters. We are a little behind last year in our total

VSC's, but I expect that number to improve as our D10 examiners submit their reports for the summer.

# Drowning Doesn't Look Like Drowning

The new captain jumped from the cockpit, fully dressed, and sprinted through the water. A former lifeguard, he kept his eyes on his victim as he headed straight for the owners who were swimming between their anchored sportfisher and the beach. "I think he thinks you're drowning," the husband said to his wife. They had been splashing each other and she had screamed but now they were just standing, neck-deep on the sand bar. "We're fine, what is he doing?" she asked, a little annoyed. "We're fine!" the husband yelled, waving him off, but his captain kept swimming hard. "Move!" he barked as he sprinted between the stunned owners. Directly behind them, not ten feet away, their nine-year-old daughter was drowning. Safely above the surface in the arms of the captain, she burst into tears. "Daddy!"

How did this captain know – from fifty feet away – what the father couldn't recognize from just ten? Drowning is not the violent, splashing, call for help that most people expect. The captain was trained to recognize drowning by experts and years of experience. The father, on the other hand, had learned what drowning looks like by watching television. If you spend time on or near the water (hint: that's all of us) then you should make sure that you and your crew knows what to look for whenever people enter the water. Until she cried a tearful, "Daddy," she hadn't made a sound. As a former Coast Guard rescue swimmer, I wasn't surprised at all by this story. Drowning is almost always a deceptively quiet event. The waving, splashing, and yelling that dra-

matic conditioning (television) prepares us to look for, is rarely seen in real life.

The Instinctive Drowning Response – so named by Francesco A. Pia, Ph.D., is what people do to avoid actual or perceived suffocation in the water. And it does not look like most people expect. There is very little splashing, no waving, and no yelling or calls for help of any kind. To get an idea of just how quiet and undramatic from the surface drowning can be, consider this: It is the number two cause of accidental death in children, age 15 and under (just behind vehicle accidents) - of the approximately 750 children who will drown next year. about 375 of them will do so within 25 yards of a parent or other adult. In ten percent of those drownings, the adult will actually watch them do it, having no idea it is happening (source: CDC). Drowning does not look like drowning -Dr. Pia, in an article in the Coast Guard's On Scene Magazine, described the instinctive drowning response like this:

- Except in rare circumstances, drowning people are physiologically unable to call out for help. The respiratory system was designed for breathing. Speech is the secondary or overlaid function. Breathing must be fulfilled, before speech occurs.
- Drowning people's mouths alternately sink below and reappear above the surface of the water. The mouths of drowning people are not above the surface of the water long

- enough for them to exhale, inhale, and call out for help. When the drowning people's mouths are above the surface, they exhale and inhale quickly as their mouths start to sink below the surface of the water.
- Drowning people cannot wave for help. Nature instinctively forces them to extend their arms laterally and press down on the water's surface. Pressing down on the surface of the water, permits drowning people to leverage their bodies so they can lift their mouths out of the water to breathe.
- 4. Throughout the Instinctive Drowning Response, drowning people cannot voluntarily control their arm movements. Physiologically, drowning people who are struggling on the surface of the water cannot stop drowning and perform voluntary movements such as waving for help, moving toward a rescuer, or reaching out for a piece of rescue equipment.
- 5. From beginning to end of the Instinctive Drowning Response people's bodies remain upright in the water, with no evidence of a supporting kick. Unless rescued by a trained lifeguard, these drowning people can only struggle on the surface of the water from 20 to 60 seconds before submersion occurs.

This doesn't mean that a person that is yelling for help and thrashing isn't in real trouble – they are experiencing aquatic distress. Not always present before the instinctive drowning response, aquatic distress doesn't last long – but unlike true drowning, these victims can still assist in their own rescue. They can grab lifelines, throw rings, etc.

Look for these other signs of drowning when persons are in the water:

Head low in the water, mouth at water level

- Head tilted back with mouth open
- Eyes glassy and empty, unable to focus
- Eyes closed
- Hair over forehead or eyes
- Not using legs Vertical
- Hyperventilating or gasping
- Trying to swim in a particular direction but not making headway
- Trying to roll over on the back

• Ladder climb, rarely out of the water.

So if a crew member falls overboard and everything looks OK – don't be too sure. Sometimes the most common indication that someone is drowning is that they don't look like they're drowning. They may just look like they are treading water and looking up at the deck. One way to be sure? Ask them, "Are you alright?" If they can answer at all – they probably are. If they return a blank stare, you may have less than 30 seconds to get to them. And parents – children playing in the water make noise. When they get quiet, you get to them and find out why.
