Welcome to the second edition of the 2019/2020 Watch Year **D10 Communicator**. As I write this article, fall is upon us and it won't be long before our boats are put away for the winter. The season always seems to go too fast! Fall does mark the half way point in the watch year and is a good time to take stock in how we are doing. As a District, through the hard work and dedication of our members, we continue to drive initiatives to lead change that is aimed at enhancing membership for all of us, while allowing our organization to resonate with a new generation passionate about boating, community service, and having fun with family and friends. The **National organization** is also moving in this direction and there was significant dialogue and debate at the Governing Board Meeting in Louisville on the actions required to en-

sure our future. I returned from the meeting with many notes to share and will be providing that feedback at the Fall Conference in a 45 minute seminar titled "Task Force Update / News from National". I hope you can attend. Slides will be posted on our website following the presentation. Speaking



of the Task Force, significant progress has been made since the Spring Conference. Recall the charter of the Task Force was to "look at potential changes in our operations to free up resources to focus on positioning D10 for the future". A team representing all squadrons has met 6 times since the Spring Conference and completed a process of (1) problem definition, (2) root cause identification for problems, (3) prioritization of root causes, and (4) recommendations for go-forward focus areas. The near term actions will be focused on membership and retention, with future actions focused on reducing bureaucracy and simplifying our operations. The details will again be provided in the Fall Conference workshop. So what about the health of our District? Like last year, we are aligning our squadrons around a common set of goals and objectives and we are on track to once again meet most. Read on for a few highlights:

Objective – Guide and support our squadrons in membership and membership retention efforts.

Overall good news in this area. As of the end of September, the District is up 35 members for the year to a total of 920. The chart at the right shows membership over the last 3 years with the blue line representing 2019. As of 9/30 we have the largest growth in the Nation both from a percentage and total number standpoint. We have achieved this through increasing new members in 4 of our squadrons, and through retention success in many squadrons. Duluth, Minnetonka, Marinette-Menominee, and St. Paul have all added new members, and Central Wisconsin, Door County, Green Bay, Madison, Marinette-Menominee, and Milwaukee have

retention levels above 90% through September. Retention continues to be a big issue at all levels of the organization. This will be the theme of the National Annual Meeting in February.

Goal - Add at least 115 new members to D10

In 2018, we smashed our goal of adding 68 new members by achieving 114. This year we set the goal at 115. To date we have added 113 new members (see the green line on chart at right)! I am confident we will achieve this goal.



Objective - Define strategies for a balanced budget in light of declining membership

If you attended the Spring Conference, you will recall we made a commitment to come forward with a balanced budget that does not rely on the use of savings. The budget we will vote on at the Fall Conference does just that through cost reduction actions. Details to be presented at the Conference.

Objective – Improve Communication between District and Squadrons to better understand and support Squadron needs.

Once again, a goal this year is to focus on communication. To this end we are continuing to publish 4 issues of the Communicator (2 historically), and plan to send at least 2 more issues of the D10 Top 10 for a total of three this year. We have also focused on reducing the number of email bounces we get on these communications and have had some success to date. We have also asked our Squadron Task Force reps to communicate regularly with their squadrons to ensure two way communication. I can't

The Award is one of the most prestigious awards that a squadron may achieve. The Award recognizes community visibility and service through a variety of local activities. It is presented under the joint sponsorship of the BoatU.S. Foundation and the USPS (America's Boating Club) through the National Squadron Development Committee.

This year changes were made to shorten the application form and what you will submit. This year there will be two Squadron Awards with \$1000 at stake!

Some helpful hints in your application to keep the submission process uncomplicated, the number of person-hours maybe estimated although keeping good records can be useful in supporting your submission. The percentage of your members involved in your activities is very helpful in judging the application received. Involvement of many members counts more than if only a few members of your squadron do all the work.

The award covers the year from October 1st through September 30th. Applications should be submitted to the National Squadron Development Committee chairman by the deadline October 15th 2019.

A few of us have just returned from the Fall Governing Board meeting in Louisville, Kentucky. My approach while attending national meetings is to bring back things which I believe can be of value to you. Please take some time to consider them and feel free to make them part of our ongoing discussions.

New Labeling of Life Jackets

You may have already noticed new labeling on recently purchased personal floatation devices. A new approach to classification has been implemented. This new labeling will bring US users in line with the international standard. Icons are used to eliminate language barrier issues. Buoyancy (lifting force) is rated by way of Newton (N) verses our US Lbs. lift. 100N and 150N labeled PFDs are classified as "Life Jackets" (equivalent to Type 2 or Type 1 respectively). All other less buoyant PFDs are classified as "Buoyancy Aids". 70N is equal to 15.75 Lbs. lift (70 x 0.225 = 15.75). 1 Newton = 0.2248 pounds of lifting force. I have a Power Point presentation for our D10 Educational workshop.

New Added Videos for the Boating Channel

As instructors or students USPS has continued the expansion of the video library. Many more are being added. One particular video "in process" will deal with ESD Electric Shock Drowning. Please take some initiative to get familiar with this resource. It will enhance our goal of more blended learning presentations.

Boat Handling 2018 Pilot Program Completed

The Seamanship Course has been rewritten and its content will be taught in a different manner. Many new options will be available to the student. The Boat Handling 2019 course will be available as a complete offering consisting of 6 seminars.

Boat Systems Committee Report

Many new and rewritten seminars are in process. *AIS Electronics for Boaters* seminar is finished and available via EBook.

Fall Squadron Educational Achievement Awards

Once again, tradition will rule the evening as we acknowledge and honor D-10 squadrons in their educational accomplishments this past year. We will be awarding the SEA award and the coveted Prince Henry trophy.


