

During the last three years of serving at the district level I have come to realize and fully appreciate how much of an impact we make in our community and its surroundings, Thank you for your service, time and enthusiastic energy!

Report from the Governing Board in Raleigh N.C.

#### District Challenges...... The topic of Regionalization

For decades, Districts have served a vital purpose as a communications conduit to squadrons, provided social interaction and networking, and presented opportunities for member and squadron engagement. Now, however we have email, phone and the web for direct communication with members. Additionally, while our organizational structure was configured and implemented when we were 80K strong, now we have just over 20K members.

Currently, many districts face challenges including the inability to fill bridge positions, a lack of attendance at district meetings and events, non-committal participation by squadrons, the continued burden of reporting and other administrative responsibilities, and insufficient resources to help weak squadrons with education and social activities. Costs - both districts and personal – often are major considerations and sometimes limitations. While not every district has these problems, many or most admit they do.

Obviously, not all districts are alike. Some are struggling just to survive and cannot meet the needs of their members and squadrons. Only a very few are large, well organized, and resource-sufficient. The majority are somewhere in the middle on a slow multi-year decline of members and squadrons.

Even for those that believe that they are successful, the outcomes do not support that conclusion. Membership continues to decline, education continues to wane, and squadrons continue to fail.

The idea of Regionalization is to consolidate resources and enhance collaboration in order to remain a viable boating and educational organization. As we have done within our district with the hard work of the Task Force the last two years. The idea is a leaner structure with 6-7 Regions would strengthen the organization in line with the current overall membership. Consolidation increases the critical mass required for strong leadership, volunteer resources, and funding with regional membership of thousands.

#### On a national level:

88% of squadrons have less than 25 members

52% of squadrons did not teach an educational course

From a District 10 perspective we are currently weighing out our options, so far since the Governing Board meeting in August we have had discussions at the most recent commander's meeting, the D10 Planning Committee is currently working on an outline to report on at the Fall Conference meeting. We would like your input, please join myself and Jim Pahl-Washa at the Conference in Eau Claire to discuss Regionalization in an ad-hoc Workshop from 8:00-9:15 prior to the Conference meeting. We should have more information from National at that time.

#### **Article 21 Defeated**

On the agenda at the National Governing Board meeting was a hot topic concerning the distribution of assets after termination. In the event of the dissolution and voluntary surrender or revocation of a squadron charter, all assets then belonging to the squadron shall be assigned to the USPS. This agenda item up for vote at the meeting was almost unanimously voted down by a vote of 204 to 4. I would like to thank all those members from District 10 providing support and lots of time and effort in defeating this proposal. A big round of applause to Commander Kevin Shutes of Minnetonka for spearheading, and bringing awareness to hundreds of members and District Commanders across the country with his well written statements against article 21. I also want to thank Greg Korstad representing the Law Committee for steering me in the right direction. I also want to thank Ben Coons, Jennine Fine, Dave Fine, Maury Rice and the rest of the District Council for supporting our vote of "Nay".














#### **Merit Marks**
