When I stepped into this role, I firmly believed that change was necessary to ensure that our organization, with its rich 100+ year heritage, would survive another hundred years and more! While I think we have a long way

to go at all levels of the organization, I believe the steps we have taken in District 10 are the right steps for our Squadrons, our District, and even the National organization. It has been an exciting two years for us, and I want to express my personal thanks to each of you for all your sup-



port, the changes you have embraced, and all that you have accomplished. Below are a few highlights. Enjoy!

REDEFINE TRADITIONS... FROM STEM TO STERN - Results

America's Boating Club – As a District, we embraced this National initiative. We set goals to modernize our websites, our newsletters, and more importantly, our culture. We coined the phrase "Living the Logo" (thanks Dale Perry) and defined what that meant through a vision and mission statement developed by the marketing team from our squadrons. This was published as the "Living the Logo Master Plan" LTL Master Plan*. The District also funded and rolled out standardized branding to all the squadrons. We put all of this on full display when we hosted the National Governing Board in Minneapolis. Feedback from all attendees we spoke with was very positive. We were even asked to make several presentations at National meetings to share what we were doing. Many of these elements were adopted by the National Planning Committee and incorporated into the National Strategic Transition Plan Strategic Plan*. Overall, I believe these efforts have helped us portray a more approachable and fun image to the boating public and it has impacted our membership.



Membership – Speaking of membership, I looked back through all the records on the National website dating back to 2000. Over those 20 years, 2018 and 2019 were the first consecutive years where D10 grew. In fact, District 10 has experienced the most growth in the Nation over the last two years. Squadrons driving this growth were Duluth, Minnetonka, Door County, and Marinette / Menominee. I believe success in these squadrons was helped by the sharing of best practices between squadrons, and the cultural and brand changes we are driving. Moving these successes across the rest of the District was a big focus of the D10 Task Force Team in 2019.

D10 Task Force Team – Last April at the Spring Conference meeting, the D10 Task Force team was formed. At the onset, the goal was to "look at potential changes in our operations to free up resources to focus on positioning D10 for the future". A multi-squadron team focused on identifying the main problems impacting our organization, and the causes of those problems. The results and recommendations were brought to the

Fall Conference and a Task Force Implementation Team was formed. That team is now focused on marketing, member involvement, and the value proposition of our organization. Have you read "Who we are and what we do: Marketing our Mission and Frequently Asked Questions."? Marketing FAQ. The efforts of this team will continue into 2020 and I personally expect it to pay dividends to all the Squadrons across D10. Come to the Spring Conference seminar on Sunday morning to learn where we are headed!



Other Ways We Excelled – There were so many other great Squadron accomplishments these last two years. It would be impossible to list them all, but here are a few more highlights:

- D10 won the BoatUS Civic Award recognizing the 938 Squadron members who donated 8132 hours!
- Over the last two years we conducted 2687 vessel safety checks which is more than any two-year period dating back to 2000.
- We submitted candidates for the Chapman award in each of the last two years (the first D10 candidates in many years). In 2018, Don Duncan won that award. The 2019 awards will be presented at the February National meeting.
- We began the rollout of Jump Start across the District. A new on the water training program designed to partner with new boaters to teach safe boating. This is a great initiative that can improve membership!
- We made the Education Fund Honor roll two years in a row by having 100% of our squadrons participate. Prior to 2018 it had been many years since we met this
- We added 238 new members over the last two years. With total membership just over 900, that is a remarkable accomplishment!
- Duluth, Minnetonka, and Door County were recognized nationally through the Member Involvement and Retention Award (MIRA)
- We revamped the format for our District Conference meetings to have an equal balance between business, education, and fun. I personally have enjoyed the increased social time with our members!
- To keep you informed and to encourage your feedback, we increased our emphasis on communication by doubling the number of newsletters, and by creating the D10 Top 10.
- With your help, we reduced the number of members we fail to reach via electronic communications.
- Many squadrons won the Distinctive Communicator award for their websites and newsletters.
- For the first time in many years we delivered a balanced budget that did not rely on drawing from savings.

Wow! I could go on but am running out of space. Congratulations and thanks to all of you! It has been an honor and a privilege to serve you as District Commander. I am looking forward to the great things this District will continue to do under the leadership of Kevin Wehrmann. See you at the Spring Conference!



Report to the 2020 District 10 Spring Conference

At the request of the District Bridge the Rules Committee has been reviewing the District Bylaws with the sole purpose of making the Fall Conference optional rather than mandatory. The request was made in response to changes adopted nationally. Therefore, the Committee recommends for approval by the Council and the Conference revisions to the District 10 bylaws, dated March 2017.

Rationale and Approach by the Committee

The new Model Bylaws (dated September 2019) provide more flexibility in District self-governance by reducing the number of <u>required</u> annual conferences from two to one. This change effectively makes future District 10 Fall Conferences optional at the discretion of the District upon the wisdom of the Council and the desire of membership to gather for business and social events. However, the bylaws being proposed do not prevent in any way the District from holding multiple conferences.

Consequently, there are several cosmetic changes involving references to spring and fall throughout, replacing specific seasonal references with the generic term "Conference" wherever possible.

Section 2.2.6 is a key addition by the new District Model Bylaws, providing the new mechanism to manage Squadron operational waivers.

This report is highlighted throughout to help the reader locate specific areas of change. There are also some additional notes in () parentheses. The proposed bylaws changes are presented in order, by Article and Section Reference. We highly recommend the reader have a current copy of District Bylaws on hand to assist with questions pertaining to each revision. The report will be explained in depth at the Council and Conference Meetings. The Rules Committee also plans to conduct an open meeting at the upcoming Conference on Friday 13 March to help answer membership questions.

Proposed Bylaws

ARTICLE 1

District Organization

Section 1.2 The district shall be composed of the chartered squadrons assigned it by the Governing Board of United States Power Squadrons. It shall be governed by a District Conference functioning as the governing body and by a District Council functioning as an executive committee of the District Conference, all in accordance with the policy and authority of USPS. If a District chooses to not have a Council, the duties herein of the Council will be the responsibility of the District Conference. (Additional sentence)

Word and Term Meaning

1.3.5 Policy and authority of USPS refers to and means the bylaws of USPS, and the policies adopted by the USPS Governing Board or the Board of Directors. The current USPS Operations Manual often includes or refers to these bylaws and policies for ease of member reference. If there is a difference between the National bylaws or USPS policy and the Operations Manual, the bylaws or policy always take precedence. (Replaced section in its entirety)

ARTICLE 2 Officers and Committees General Provisions

- 2.1.5 No individual shall be eligible for election to the office of commander for more than two consecutive terms of one vear each. The following sections were renumbered to match 2019 model after deleting current 2.1.5
- 2.1.5 Committees whose members have staggered terms shall have members elected or appointed initially for terms to meet such qualifications. One of the members whose term next expires shall be considered for appointment as chairman except for the general committees, which shall select their own chairmen.
- 2.1.6 A vacancy occurring in any elective office shall be filled by the Council for the unexpired term and a vacancy occurring in any appointive office shall be filled by appointment by the commander except for multi-year terms which shall be appointed by the Council. Persons selected to fill vacancies in the offices of educational officer and assistant educational officer must have their qualifications approved as provided in 6.3 herein.
- 2.1.7 In addition to the specific duties set forth herein, all district officers shall be expected to perform such other duties relating to their office as may be prescribed by the policy and authority of USPS.
- **2.1.8** In all instances relating to rank, grade, appointment, duties, and procedures, the policy and authority of USPS shall prevail.
- **2.1.9** Upon leaving office, officers shall turn over to their successors all significant records, reports, communications and documents in their possession that pertain to the affairs of the district.

Elected Officers

2.2.6 Evaluate in coordination with the National Executive Officer requests from squadrons of the district for a temporary waiver to its bylaws to conduct its affairs under such organizational and operational structure as deemed appropriate. Monitor said squadron and its activities and report to the National Executive Officer. (New: Squadron Waiver rule)

General Committees

- 2.9.3 The Auditing Committee shall consist of a chairman and two other members, one of whom shall be elected each year for a term of three years. This committee shall examine all records of the treasurer annually and submit a report of its findings to the next meeting of the Conference. An additional financial review shall be performed should a different person assume the office of treasurer prior to the end of the fiscal year.
- 2.9.4 The Planning Committee shall consist of a chairman and five other members, two of whom shall be elected each year for a term of three years. If practical, this committee shall be so constituted that at least half the members are past district commanders or past district lieutenant commanders and with not more than one member from any one squadron. This committee shall make recommendations for proposed changes benefiting the district in response to requests from the Council, the Conference, or from within the committee. It shall file a report to the next meeting of the Conference.

Standing Committee (Reporting to the Council)

Section 2.10.1

The **Budget and Finance Committee** shall consist of three members, one of whom shall be appointed by the Council each year for a term of three years. This committee shall recommend policy concerning general reserves and operating funds as directed by the Council, and shall annually draft a detailed budget of operating expenses, anticipated income, and recommended assessment to be levied against the squadrons for the following budget year. The complete budget shall be proposed to the Council prior to the Conference. Any change in assessment adopted at a Conference shall not take effect until the beginning of the next USPS dues year. (According to new model language)

ARTICLE 3 The Council

Section 3.2.4 The Council shall:

At least annually, prior to the Conference at which the budget is adopted, approve for recommendation to the Conference a detailed budget, including the assessment to be levied against squadrons for the following year and any investment decisions, to be forwarded to Conference for final approval. (Replacement)

Section 3.2.8 The Council shall:

Appoint annually a member(s) to the Budget and Finance Committee to replace the member(s) completing their final year of service. (Modified per new bylaws language)

Section 3.2.10 The Council shall:

For all district operating funds, and with the advice of the treasurer, designate depositories insured by an agency of the U.S. government in which the district's operating funds shall be kept. For planning purposes, operating funds shall approximate 150% of the district's annual operating budget. For investment funds, the district may seek out higher yield investments which have been recommended by a qualified professional. Finally, the Council shall adopt the budget, including any investment decisions, for submission to the next Conference for final approval.

ARTICLE 4 The Conference

Section 4.2 Delegates.

4.2.1 Delegates shall be selected by each squadron from that squadron's members qualified to vote on the basis of one delegate for each 25 members so qualified and in good standing, or major fraction thereof, as of the preceding 1 March, with a minimum of three delegates per squadron.

Section 4.3.1 The Conference shall:

Elect annually elective officers as provided herein and members of the general committees. (Remove reference to spring)

Section 4.3.2 The Conference shall:

Adopt annually a detailed budget, including the assessment to be levied against squadrons. Assessments for members joining squadrons after the date specified in 2.7.6 herein may be levied by the Conference. Assessments shall not be levied upon squadrons of a division of the district without authority of the Division Conference. (Remove reference to fall meeting)

Section 4.3.5 The Conference shall:

Adopt and forward appropriate recommendations and resolutions, which have been adopted by a two-thirds vote of the District Conference, via the office of the national Executive Officer for final decision by the Governing Board. A subsequent District Conference may, by a two-thirds majority of those voting, move to withdraw a resolution still pending before the Governing Board, a department committee or officer of the USPS. (Replacement)

ARTICLE 5 Meetings, Notices, and Quorums

Section 5.1

There shall be at least one regular meeting of the Conference in each calendar year. Any Conference meeting shall be scheduled in accordance with the policy and authority of USPS and care shall be taken that the dates do not conflict with national events. (Replacement)

Section 5.2

The Council shall fix the number of its regular meetings provided, however, that there shall be at least one, which shall be held within 40 days prior to the following Conference. (Replacement)

Section 5.6

Notice of any district meeting shall be sent by the secretary to members of the Council not less than 30 days prior to the date of a regular meeting and not less than 15 days prior to the date of a special meeting. For meetings of the Conference: (1) notice shall also be sent to each past district commander of the district; (2) the squadron commanders shall notify their respective delegates; and (3) notice of the Conference at which elections are held shall include a list of members nominated by the Nominating Committee for election to positions within the district. Publication of notices in a regular district publication, duly and timely circulated, shall fulfill the foregoing requirements.

Section 5.8.3

In the absence of a squadron commander, the squadron executive officer or administrative officer may act for the commander in the order indicated, except that if the executive officer and the administrative officer are both absent, the squadron commander may appoint an active member of the commander's squadron to act for the commander. Such appointment shall be in writing or by e-mail and submitted to the district secretary at or prior to the meeting. In the absence of an officer for whom there is an elected assistant; the assistant may act for the principal. (Replacement)

ARTICLE 6

Nominations and Elections

Section 6.1 Candidates for elective offices to be voted on at Conference shall be nominated by the Nominating Committee or by written petition signed by a total of at least 10 acting members in good standing from each of at least three squadrons. Such petition shall be sent by first class mail or delivered to the secretary at least 15 days before the date of the election. At least 10 days before the date of the election, the secretary shall forward the names of those nominated by petition to each member of the Council and to each past district commander of the district. Squadron commanders shall notify delegates representing their squadrons. Electronic notification shall be considered effective provided the conditions of Section 5.6.1 are met.

Section 6.6 In the event the commander, the executive officer, or the administrative officer is determined, by self-declaration or by two-thirds vote of the Council, to be incapable of performing the duties of office because of illness or other reason, the Council may assign the duties and powers of such office to a past district commander agreeable to serve. Such assumption of duties by a past commander shall last only until the earliest of: (1) the next Conference; (2) the officer rescinds the self-declaration of incapability; (3) the Council rescinds its declaration of incapability; or (4) the next meeting of the Conference at least 50 days after the declaration of incapability at which meeting the Council shall recommend to the Conference whether the period of incapability should be extended or the office should be declared vacant. Should the Council recommend the office be declared vacant, such recommendation shall be made in time for a report of the Nominating Committee to be included in the notice of the meeting of the Conference. If the Conference by a two-thirds vote concurs, an election shall be held to fill such vacancy. Candidates for such office shall be nominated according to the provisions of 6.1 and 6.2 above.

ARTICLE 8

Finances

Section 8.2 The budget year of the district shall be from the end of the Conference at which the budget is adopted to the end of the Conference at which the budget is adopted the following year if only one conference is held annually. Otherwise the budget takes effect according to 2.10.1. (Replacement with one minor addition to acknowledge budget approvals in the Fall taking effect the following dues year after the Spring Conference)
