Back in April/May Ben Coons and Greg Korstad organized a team of instructors to offer and conduct for the first time ever an online ABC3 Virtual Classroom through Advanced Wireless based in Lakeville. From the MN Department of Natural Resources, Conservation Officer Joe Kullanek was on hand "LIVE" to present the ins and outs of State Law to the 26 students that signed up and paid for the course.

Fall Conference in Eau Claire 2020 Cancelled on August 25

On August 25the D-10 Bridge held an emergency council meeting to vote on whether to continue with the conference or cancel the conference because of the concerns with Covid 19. Within the last month we surveyed the general membership which included all 11 squadrons located in the upper Midwest – to ask whether they would consider attending the meeting. 82% of the respondents replied NO and indicated avoidance of the risk of COVID-19 exposure was the reason for their response.

What's Next: The Metropolis Resort was willing to retain our deposit of \$420.00, without penalty, toward our reservation for October 22-24 of 2021. Thank you, Cdr. Ed Manor and Kris Harmon from St. Paul Squadron, they have agreed to host the next Fall Conference at the Metropolis in Eau Claire next year.

The General Membership Meeting will be held Online in one form or another on the morning of Saturday October 31st. This online version of the meeting will give everyone in District 10 a chance to attend. This meeting is open to ALL members of District 10. Please mark your calendars, we may offer a couple online seminars as well.

<u>Rendezvous 2021 – 22</u>

Cdr. Chad Lowney from the Duluth Squadron has agreed to host the Rendezvous During Labor Day weekend September 4-6, 2021.

Cdr. Bob DeNoto from Door County announced that the Rendezvous to be held in 2021 in Door County will be pushed back one year. Concerns over the completion of the Maritime Museum will put us on hold. Look for a Rendezvous date sometime in the Fall of 2022.

Once again, another boating season is starting to wind down. COVID-19 was not able to stop many of us from getting out and social distancing on the water. I wish all of you a successful rest of the season.

ABC3 (America's Boating Course)

Virtual education has been the order of the day for most of the USPS 41 states.

Offering ABC3 via Emergency Virtual Classroom (EVC) was initiated and quickly gained approval by NASBLA (National Association of Boating Law Administrators) and many states. This emergency continues beyond the initial expiration date of 30 June in several states. This is offered as a temporary solution in areas that prohibit classroom education during the COVID-19 period. This program essentially provides an online avenue for completion of the classroom ABC3 course.

As of late August USPS reports 24 EVC classes with 269 students enrolled.

Question: What is the current status for District 10?

Answer: The EVC program has been extended through 30 September in both Minnesota and Wisconsin. Michigan expires 31 August.

We had one very successful virtual classroom of ABC3 within Minnesota.

We need to thank Ben Coons for his leadership in conducting a virtual class of ABC3 online during this past May/June. Ben assembled a team from the Minnesota area and the effort had an enrollment of 24 students. Ben's program was based on the current online ABC course. I might also add that the state of Minnesota was the first state to approve an EVC approach. EVC needed approval by both NASBLA and each individual state BLA prior to implementation.
