




# National Boat Safety Week May 20-26

Cooperative Charting – 2023 Honor Roll Requirements By Sandra Broekema

Did you know that the Cooperative Charting Committee establishes annual (calendar year) criteria for Individual and Squadron Honor Roll requirements based on your latitude and membership participation rates? That's right! Northern based squadrons, like those in D10, have lower individual and squadron Honor Roll credit requirements than more southerly based squadrons who can boat and recover markers year round. Snowy winters certainly hinder searching for and recovering geodetic survey markers mounted on or in the ground!

The #1 Individual, Squadron and District are awarded annually based on the resultant percentage of honor roll requirements in order to level the playing field with respect to latitude (weather) and size of squadron.

So, how do you earn credits? By registering and submitting documented reports on Geodetic Survey Markers, Marina Surveys and/or Nautical Aids to Navigation, Bridges and Charts. The credit values are found in the Standard Operating Procedures under the Executive Department on the National Website log in (www.usps.org/departments/12000/12200) scroll all the way down to the bottom of the page. It is summarized for your convenience below:

#### 2023 Annual Meeting Report By District 10



The D/C and DXO meeting was held on 23 February 2023 at 0930-1600, led by National Administrative Officer Ralph Bernard, at the Rozen Plaza in Orlando, FA. DXO Jennine Fine and P/D/C Dave Fine were in attendance. 27 of 29 Districts were represented, including D10.

<u>Chief Commander Craig Fraser</u> addressed the body covering the following points:

- · There will be electronic voting at the Annual Meeting.
- The Cyber squadron is comprised of approximately 1500 members paying average dues to National, District, & Squadron. Dues are \$105 for individual members and \$150 for family members. It was recommended for squadrons to seek out these members and invite them to join their squadrons. Squadrons should entice them by telling them about their Educational and Civic activities. The marketing rule is to invite them 7 times.
- The National Headquarters Membership Management Systems (currently being created) will enable auto renewals and set up a website for event planning which will include National, District, and Squadron events. It is expected the new system will also allow all squadrons to utilize eCommerce.

<u>Rules Committee represented by Al Larkin</u> spoke about the proposed by-laws changes which covered:

Full Implementation of Electronic voting amendments. He expects that
there will be voting problems as many don't have smart phones. He
explained that multiple voting will be controlled by individual logins for all
voters. This motion was approved at the Annual Meeting.

#### News from National (continued)

 The composition of the Finance Committee will be not less than three nor more than 5 members. This will mirror the composition of other existing committees. This motion was defeated at the Annual Meeting.

 The Effective date of dues motion will change from 30 to 60 days to allow HQ time to complete payments-in-process. This motion was approved at the Annual Meeting.

#### National Administrative Officer Ralph Bernard spoke about the following items:

- District Officers should fill out the OD-1 to include the 2023 Slate of Officers and Change of Watch Date. On that note, Squadron Officers should fill out the OD-2 to update the 2023 Slate of Officers and COW date.
- HQ discontinued collecting Dan Boater dues. Any such payments should be made directly to Dan Boater.
- Management IMS for auto renewal will replace the current person working at HQ.
- 10 Squadrons in District 11 will be dissolved. The 2 remaining squadrons will merge into District 7. This motion was approved at the Annual Meeting.
- The financial highlights of 2022 were:
  - Operating Expenses took a loss of \$98K including an investment loss of \$135K, educational sales down \$6K (due to free books for ABC), and an increase of liability/property insurance increase up \$20K in 2023 and another increase of \$26K in 2024.
  - Dues have not increased since 2017. The rate of inflation since then has been 21%. Social Security is up 8%.
  - Rearick Donation of \$500K will cover some of the cost of the Management IMS (\$100K) and HQ building issues.
  - The actual increase in dues will be \$5 for individuals and \$7.50 for families or \$60 for individuals and \$90 for families. This motion was approved at the Annual Meeting.

# <u>Tom Hancock spoke about Co-Operative Charting</u> which is composed of the following 3 areas:

 <u>Nautical</u>. 2 Apps are available. The NOAH is a coastal marker app updated by the US Army Corp of Engineering. The ATONS app is updated by the US Coast Guard. News from National (continued)

<u>AdHoc Committee members Alan Bombard and Tracy Simpson</u> presented a power point which can be requested at <u>District28abc@gmail.com</u>. This presentation covered:

- Plans to stimulate districts and squadrons to perform simplification, encourage electronic voting, and Educational Department modernization.
- Improvements on Communication is ongoing through the Squadron Education and Activities Scheduler (SEAS).
- National to combine the two websites (ABClub & USPS Website).
- In closing it was quoted that "Hope is not a Strategy" and "We must continue to Move Forward".

#### Additional motion Approved at the Annual Meeting

A motion at the Governing Board in Raleigh to make educational instructor
materials available to all squadron SEO's at no charge. This was tabled at
the Governing Board with the action for the National Education Officer to
study and make a recommendation at the Annual Meeting. This was
brought to the floor with a recommendation from the NEO against
adoption. An amendment to this motion was made to offer free Electronic
Instructor Manuals. After much debate, the vote was called and approved.

#### Annual Meeting Electronic Voting and Virtual Meeting Attendance Thoughts

- Overall, the virtual meeting worked quite well. There were over 500
  members in attendance both virtually and in person. In the last several
  meetings, attendance has been less than 250.
- Electronic voting started bumpy but worked very well. This allowed many more squadrons to vote directly. For the vote to increase dues nearly 400 votes were cast and the motion passed with 67% for and 33% against.

#### D10 Awards went out to:

- Life Members Gregory M. Holmen, AP (St. Paul) and Carl G. Jansen, AP (Oshkosh)
- BoatUS Civic Award recognized Green Bay which was 1 of 7 candidates.
- D10's 11 squadrons received Honor Role status for the Education Fund.
   100% participation for D10.



We currently have \$41,891.67 in the bank (in the accounts summarized below):

\$ 18.877.37 Checking

\$ 6,237.44 Enrichment Fund \$ 8,073.14 General Savings

\$ 4,503.49 Savings – Reserve Fund

This total is \$3,775 less than last spring.

The Enrichments Fund is available for any of the District squadrons to submit an Application for up to \$500 to help launch a squadron membership, education, civic, fraternal, or administrative initiative. Please find this form on the district website under forms.

The watch year end is March 31, 2023. All of the books and records are up to date and filed accordingly. The bank statements are reconciled on a timely basis each month.

As the district uses an accrual accounting system, anything incurred at the Spring Conference will be added to the watch year ended March 31, 2023. I will be working with the audit committee to audit the 2022-2023 watch year after it is finalized.

We are not planning on an increase in District Dues from the current \$19/year for Primary Active Members and \$26/year for Family Membership. However, National raised dues \$5 for individual and \$7.50 for family membership.

The Budget for the next watch year is presented at the Fall Conference in the past - Overview of the Annual Budget Approval Process:

- 1. The Bridge & the Budget and Finance Committee work together with the Treasurer to propose a Budget for the coming year.
- 2. The Bridge & the Budget and Finance Committee review the proposed budget and make a recommendation to approve or revise based on available funds.
- 3. The Bridge reviews the Committee's recommendations and makes changes if required.
- 4. The council reviews/discusses and approves or disapproves the proposed Budget prior to the Conference.
- 5. The Conference delegation reviews/discusses and approves or disapproves the proposed Budg-


